

**ADDENDUM NO. 1**

This Addendum No. 1 is made on the 03<sup>rd</sup> day of the month of April, 2012 between Joint Venture of NK – NEC – Chodai – TEC (hereinafter referred to as the “Consultant”) on the one part, and E&R Engineering Consultants Joint Stock Company (hereinafter referred to as the “Sub-Consultant”) on the other part, concerning the Principle Contract dated August 22<sup>nd</sup>, 2011 for Topographic survey works for Detailed Design for Da Nang - Quang Ngai Expressway Development Project (hereinafter referred to as the “Principle Contract”); Contract dated December 02<sup>nd</sup>, 2011 (hereinafter referred to as the “Contract”);

WHEREAS, The JV was issued Certificate of Seal by Ministry of Public Security dated 30<sup>th</sup> March, 2012 ;

WHEREAS, The JV was issued Certificate of Tax Registration by Ministry of Finance dated 15<sup>th</sup> March, 2012 ;

NOW THEREFORE, it is mutually agreed by and between the parties hereto as follows:

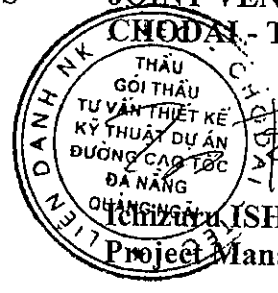
1. The Tax code of the Joint Venture of NK – NEC – CHODAI – TEC of the Contract will be supplemented as: 0401482174.
