

**ADDENDUM NO. 1**

**WITNESSETH:**

WHEREAS, Joint Venture of NK – NEC – Chodai – TEC was issued Certificate of Office Registration No.852/SXD-VP by Da Nang's Construction Department dated 21<sup>st</sup> March, 2012;

WHEREAS, Joint Venture of NK – NEC – Chodai – TEC was issued Certificate of Seal by Ministry of Public Security dated 30<sup>th</sup> March, 2012 ;

WHEREAS, Joint Venture of NK – NEC – Chodai – TEC was issued Certificate of Tax Registration by Ministry of Finance dated 15<sup>th</sup> March, 2012 ;

This Addendum No. 1 is made on the 03<sup>rd</sup> day of the month of April, 2012 among:

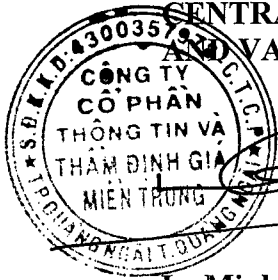
- Nippon Koei Co., Ltd. duly organized and existing under the laws of Japan, with its principal office located in 4, Kojimachi 5-chome, Chiyoda-ku, Tokyo, 102-8539 Japan (hereinafter referred to as the "Consultant"); and

2. Add the following new sub-clauses 8 after sub-clause 7 of Clause 2.12. Terms of payment of the Contract:
  8. The Sub-consultant shall issue VAT invoice for each payment.
3. All contents of the Contract not specifically modified by this ADDENDUM NO. 1 shall remain unchanged and in full force and effect.

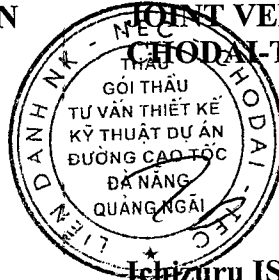

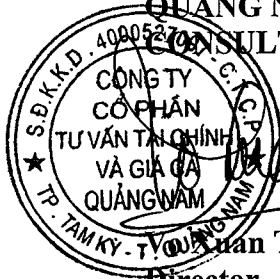

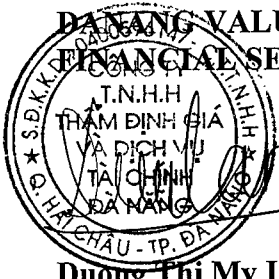
