This Addendum No. 2 is made on the 04<sup>th</sup> day of the month of May, 2013 between Joint Venture of NK - NEC - CHODAI - TEC (hereinafter referred to as "Consultant") on the one part, and Joint Venture of independent valuation consultancy companies of Da Nang - Quang Nam - Quang Ngai (hereinafter referred to as "Sub-consultant") on the other part, concerning the Contract dated January 30, 2012 for independent replacement cost survey (hereinafter referred to as "the Original Contract") and the Addendum No.1 dated 03<sup>rd</sup> April 2013.

**WITNESSETH:**

WHEREAS, the response from JV by the Letter No.DQEDD-RCS-01-13 dated 03<sup>rd</sup> May 2012 regarding your request on 2<sup>nd</sup> payment.

WHEREAS, it was mutually agreed in ARTICLE 2.12: TERMS OF PAYMENT of the Original Contract that "Second payment equivalent to Forty percent (40%) of the Contract price shall be made to the Sub-consultant upon acceptance of the outcome by the Consultant". However, in order to support the Sub-consultant to speed up the progress well, the second payment should be modified.

NOW THEREFORE, it is mutually agreed by and between the parties hereto as follows:

**1. Terms of payment.**

Terms of payment No.2.12.4 shall be deleted and replaced in its entirety with the following;

4.1. Second payment equivalent to Twenty percent (20%) of the Contract Price shall be made to the Sub-consultant upon acceptance of report, both English and Vietnamese, on reoplacement price proposal for 12 districts/cities by the Consultant.;

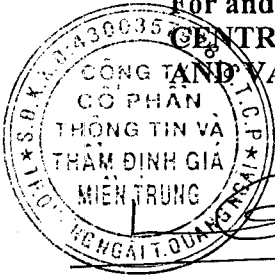
4.2. Third payment equivalent to Twenty percent (20%) of the Contract Price shall be made to the Sub-consultant upon acceptance of the outcome by the Consultant.

**2. Other Content:** All contents of the Contract and Addendum No.1 not specifically modified by this ADDENDUM NO. 2 shall remain unchanged and in full force and effect.
